

中文摘要

關鍵詞：水上運動/海洋活動/漁業碼頭

海洋除作為漁業之利用之外，亦是海洋運動遊憩休閒的活動場所，本計畫研討海域空間多元化之利用，研析台北縣地區漁業碼頭設施之現狀與未來規劃，評估運用漁港發展海洋運動的可行性，並對可能之發展方向提出具體之策略。

適合運用漁港來進出海岸之海洋活動，包括：船釣、船潛、遊艇、中、大型帆船等活動，但這些活動之推展，並不合適應用已經使用率甚低，幾乎已沒有港口功能的漁港來重新規劃建設，較適合運用已經規劃有觀光、休閒、遊憩、文教等多功能的漁港來發展。建議透過行政院院務會議或行政院海洋事務推動委員會，協調並責成漁政單位將海洋運動納入規劃為漁港多元化功能之一，並釋放出部分碼頭泊位，提供給船釣、船潛、遊艇、中、大型帆船所使用。

至於海泳、浮潛、岸際水肺潛水、獨木舟、風浪板、衝浪、小型帆船等活動，則可協調交通部觀光局督促「北海岸及觀音山國家風景區管理處」、「東北角海岸風景區管理處」，在規劃近岸海域遊憩活動時，增加親水性之軟硬體建設，方便浮潛、岸際水肺潛水、獨木舟、風浪板、衝浪、小型帆船等活動人員進出海域。

體委會除了擬定與其他行政單位之間的協調策略之外，對漁港地區的基層單位，包括漁民、漁會、縣市府派駐的漁管所、海巡檢查哨等，須有具體可行之溝通、輔導、獎勵辦法，以便一方面增加策略推動之助力，一方面減少執行層面之阻力。

In addition to the fishery activities, fishery harbor can also be served as a base for other ocean activities, such as: sports fishing, yachting, sailing, water skiing, diving, surfing, wind-surfing, kayaking, snorkeling, and swimming. In Taiwan, until today, most fishery harbors were designed and functioned solely for fishery purpose only. How to modify and/or enlarge the functions of the fishery harbors so as to engage with ocean activities were evaluated in this study.

Ocean activities, such as: sports fishing, yachting, sailing, boat diving, are suitable to use fishery harbor as a base. But, for these activities, it is not proper to use those traditional small fishery harbors due to their original design are solely for fishery only and there will be too much hustle to modified their present facilities so as to suitable for other ocean activities. It is better to use those multiple-purpose larger modern fishery harbors because there are facilities and spaces to add in the functions of extra ocean activities.

As for the activities such as shore diving, surfing, windsurfing, kayaking, snorkeling, swimming, and small sailboat sailing, fishery harbor is not absolutely required. These activities can simply get in and out of the ocean through coastal areas. It is suggested that more sea accessible design in the coastal areas should be considered in Taipei County coastal areas.

Strategically, efforts should be made to promote the recognition and mutual understanding between governmental agencies that ocean sports can be one of the functions of the

fishery harbors. And technically, activities such as exhibitions of the ocean sports equipment, seminars, training camps, and may be ocean carnivals should be held more often at the fishery harbors by both the ocean people and the local fishery organizations so as to let the local fishermen familiar with the ocean sports and engaged with these activities by and by. This will not only reduce the local resistances but also enhance the assistances.
